

To be added to the **Firearm Litigation listserv**, please email [Mike\\_McConnell@fd.org](mailto:Mike_McConnell@fd.org) or [Cullen\\_Macbeth@fd.org](mailto:Cullen_Macbeth@fd.org) and write “I’d ask to be added to the FDO Firearm Litigation listserv.” All AFPDs and CJA panel attorneys are welcome to sign up.

To obtain access to the “**Firearm Litigation**” folder on **box.com**, you will need:

(1) a box.com account, and (2) either (a) to be a current federal defender employee with an fd.org email address, or (b) to have current access to [www.fd.org](http://www.fd.org), the website of the Training Division of the Defender Services Office. Please note that each folder on box.com require separate permission; prior permission to access folders such as Defending in the Age of COVID19 will not allow you access to the Firearm Litigation folder.

**If you ARE a current federal defender employee with an fd.org email address:**

1. If you do not have a box.com account under your fd.org email address, apply for one: <https://app.box.com/signup/n/personal>
2. Once you have obtained a box.com account, please email [Carl\\_Adams@fd.org](mailto:Carl_Adams@fd.org) and write: “I have a box.com account. Please add me as a ‘viewer’ to the box folder ‘**Firearm Litigation**’”

**If you are NOT a federal defender employee but you DO currently have access to [www.fd.org](http://www.fd.org):**

1. If you do not have a box.com account, apply for one: <https://app.box.com/signup/n/personal>
2. Once you have obtained a box.com account, please email [Carl\\_Adams@fd.org](mailto:Carl_Adams@fd.org) and write: ““I have access to fd.org and a box.com account. Please add me as a ‘viewer’ to the box folder ‘**Firearm Litigation**’”

**If you are NOT a federal defender employee and you do NOT have access to [www.fd.org](http://www.fd.org):**

3. When you have both (a) access to [www.fd.org](http://www.fd.org), and (b) a box.com account, please email [Carl\\_Adams@fd.org](mailto:Carl_Adams@fd.org) and write: “I have access to fd.org and a box.com account. Please add me as a ‘viewer’ to the box folder ‘**Firearm Litigation**’”
